CORE Core Privileges

BASIC Core NP Privileges (These privileges apply to all NPs)

Initial and ongoing assessment of a patient's medical, physical, and psychosocial status including:

1. Completing histories and physical examinations
2. Developing treatment plans, goals of care, and advanced care plans
3. Performing daily rounds
4. Establishing primary and secondary diagnoses as well as determining complications, comorbidities, and present on admission (POA) conditions
5. Providing general or specialty consultation to other providers
6. Recording of progress notes as required by the medical center policies and procedures
7. Ordering diagnostic tests, monitoring, and therapeutic modalities such as medications, treatments, and examinations
8. Initiating referrals to appropriate physicians or other healthcare professionals
9. Instructing, educating, and counseling patients and families concerning health status, results of tests, disease processes, and discharge instructions
10. Planning discharges and writing discharge summaries
11. Ordering rehab and respiratory therapy
12. Ordering durable medical equipment
13. Ordering home health services and supplies
14. Determining disability and work status

Provisional core privileges are granted based on license type and successfully completing the UCSF credentialing process.

Core privileges are granted after the NP has demonstrated competency through the FPPE process and submitted at least five activity logs via the [UCMe e-Log system](#). OMAG identifies approved privileges on the [ECHO website](#).

Maintenance/Renewal Criteria:

Assess, stabilize, and determine disposition of pediatric patients with emergent conditions consistent with medical staff policy regarding emergency and consultative call services.

PEDT Pediatric Emergency Transport

For patients being admitted to a Pediatric Unit, from age birth to 18 years and adults with congenital/pediatric genetic disorders. Includes both air and ground transport, as well as medical management at referring hospital

Initial Criteria: Demonstrated competence in Intubation, Arterial Line Placement, Thoracentesis, and Chest Tube Placement before completion of orientation and going on transport without preceptor

NEO Neonatal

Initial and ongoing assessment of pediatric patients in the Intensive Care Nursery for the patient's medical, physical, and psychosocial status including taking and recording history, analyzing history and physical information to develop appropriate differential diagnoses, ordering and interpreting diagnostic tests, physical and occupational therapies, and examinations. Administration of medications and performing advanced procedures and delivery room resuscitation.

Instruct, educate, and counsel families concerning health status, results of tests, disease processes, and discharge plans, write/dictate discharge summaries, initiate referrals to appropriate physician or other healthcare professionals

Medication Abortion (Adult, Peds)

The APP must review and understand sections 2 and 6 of the National Abortion Federation's Clinical Policy Guidelines for Abortion Care, complete the Prescriber Agreement Form, and either attend department sponsored training or complete accredited continuing education training specific to prescribing medications for abortions. Proof of completion must be submitted to the Office of Medical Affairs and Governance (OMAG).
